Submission of the West of England Joint Spatial Plan

The four West of England Councils - Bath and North East Somerset, Bristol City, North Somerset, and South Gloucestershire have prepared a **West of England Joint Spatial Plan**. The Plan sets out the policies and principles for determining the most appropriate and sustainable locations for future development to meet its **housing, employment and transport needs for the next 20 years, to 2036**. This plan will sit above and guide each council's own Local Plan.

You have previously commented on the Joint Spatial Plan and I am writing to you to let you know the West of England Joint Spatial Plan (JSP) was submitted to the Secretary of State on the 13th April 2018.

The JSP will now be examined for its compliance with statutory requirements and on its soundness. Inspector Mr Malcolm Rivett BA (Hons) MSc MRTPI has been appointed to conduct the examination and determine whether the JSP is sound and legally compliant. He will be assisted by Mr Steven Lee BA (Hons) MA MRTPI.

The two Inspectors will have particular regard to the representations made on the JSP Publication Plan.

Alongside the Plan, a number of evidence base documents were also submitted for Examination including:

- Sustainability Appraisal report



- Proposed changes to the Policies Map
- Engagement and consultation main issues report
- A copy of the representations made in respect of the proposed submission of the JSP Plan.
